

**Selectmen's Meeting Minutes**  
**March 10, 2015 - Fuller Town Hall @ 9:00 a.m.**

Selectmen present: Rheaume, Ladd and Brooks: Jamie Sayen and Suzanne Goulet

Jamie Sayen, Town Moderator asked if the town's people adopt the night Town Meeting will the hours still 10:00 am to 7:00 pm? The Selectmen said yes. Jamie said that he would be opening the Town Meeting with ground rules. Jamie also said that he would explain Article 3 when he gets there and that he will only be allowing people to speak to the Article only, no personal attacks.

The Selectmen asked Jamie if he could announce that there are handouts at the back of the room if anyone would like and if he could please instruct people to stand up when they are speaking.

Suzanne gave Robin a Thank You card signed by Office Staff since this was her last day as Selectmen. Thank You Robin for all of your hard work and dedication to the job! You will be missed!! Robin said that it has been a great learning experience.

Tim said that he is still trying to find Randy LeClair about the Twofoot trailer. Suzanne said that the Trailer Park owner said that he might be interested but he hasn't gotten back to her yet. Suzanne also said that she called NHMA and they told her that any sale of property does not need to be advertised in the newspaper. The Selectmen said that we need to be careful because we don't want people accusing us of having a "Good Old Boy's Club" but in this situation it would be okay.

The Selectmen discussed meeting next Monday and then decided to just wait the two weeks.

Suzanne said that Dawn told her that Article 3 can not be posted in the Voting Booths.

Suzanne spoke to the Selectmen about the Fuel Savings from the Old Office to the New Office. Just from January to March 2015 there has been a \$5,800+ savings.

Bona brought up an incident that happened during the week. Bona said that Michael Brauer came in to the office on Tuesday March 3<sup>rd</sup>, 2015 to ask what the Selectmen signed the day before and Bona told him that they signed the Manifest and a Reservation Form for Speedway 51. Mr. Brauer asked if there has been any discussion about his property and Bona said no. Mr. Brauer also asked who was running for Selectmen and Bona told him Jamie Davis and Mike Miller. Mr. Brauer asked if Jamie Davis was the guy that has been coming to the Selectmen's Meetings and Bona said yes. Mr. Brauer asked if Jamie knows Tim Brooks and Bona told him that she thought they were friends. As Mr. Brauer was leaving he told Bona that she should also be concerned if he is a homosexual because she is Catholic. The Selectmen said that the whole Board is in agreement that they whole heartedly do not discriminate. Wayne, who was present at the meeting, said that he can not get involved.

Jamie Sayen said that he will expect the people at Town Meeting to follow the Rules and he will have Wayne remove anyone who is out of order.

Robin said that anytime that she can be of help she would be more than happy to.

Larry said that he got the map for the Hollow Section of Streetlights and also reported that the streetlight in front of Thurman Blodgett's house is out so the office will need to call that in.

Tim and Larry said that they would come to sign the Manifest next Monday.
