The meeting was called to order at 3:30 pm by Chairman Jamie Davis.

APPOINTMENTS: Josiah addressed the Board concerning Training for Supervisors of the Checklist.

Josiah addressed the Board about the Town Auditor Position, Write-Ins for the position and what he discovered about dissolving this position in the future.
